

BY THE REQUEST OF THE MASON COUNTY EMERGENCY SERVICES AND THE ORDER OF THE MASON COUNTY COMMISSION, ALL RESIDENTS AND VISITORS ARE HERBY ADVISED THAT AN OUTDOOR BURNING BAN IS INEFFECT SEPTEMBER 19, 2024, UNTIL FURHTER NOTICE:

ALL OUTDOOR BURNING IS PROHIBITED IN
MASON COUNTY, WV

This ban prohibits all outdoor burning throughout Mason County until the ban is lifted by the Mason County Commission. Mason County has been significantly impacted by extreme drought conditions and widespread wildfires, resulting in severe damage to private property and an increased threat to life and safety.

This is due to abnormally dry weather conditions forecast by the National Weather Service.


