The tower will be constructed on the Putnam/Mason line, starting in March 2025, and the total cost projection is \$1,454,000.

Upon motion by Nibert and unanimous agreement, the Commission approved Estate Appointments, Affidavits for Small Estates, Orders Appointing Fiduciary Commissioners, Waivers of Final Settlements, Reports of Receipts and Disbursements, Commissioner's Reports of Claims and Final Settlement, and Applications for Corrections of Erroneous Assessments. Upon motion by Nibert and unanimous agreement, the Commission minutes from the previous meeting were approved with no omissions or corrections thereto.

The Commission executed the Bills and Purchase Orders as required.

Upon motion by Nibert and unanimous agreement, the Commission awarded the annual courthouse IT contract to Global Science Technologies.

Bechtle updated the Commission on the courthouse basement sewer project which should start in the next 2 to 3 weeks.
