THE COUNTY COMMISSION OF MASON COUNTY met in the Commission room of the courthouse on Thursday, April 10, 2025, at 4:00 p.m. in regular session. Present were Rick Handley, President; Sam Nibert, Commissioner; Chris Johnson, Commissioner; Diana Cromley, County Clerk; and Jason Bechtle, Administrator.

Rick Handley called the meeting to order. Diana Cromley gave the opening prayer, and Sam Nibert led the pledge of allegiance.

J. T. Thomas with the Letart Nature Park Committee provided an annual update on the Nature Park. The need for a survey of the property was discussed, and the Commission agreed to obtain bids from surveyors. The Commission gave its approval to a request received by the Park Committee for a bowhunters class to use the Park.

Ed Cromley appeared in support of Pickleball Month. Upon motion by Nibert and unanimous agreement, the Commission approved a Resolution declaring April 2025 as Pickleball Month in Mason County. A copy of said Resolution is attached.

Greg Fowler with the Mason County Prevention Coalition discussed an Opioid Prevention Program for Wahama and Hannan High Schools. Upon motion by Johnson and unanimous agreement, the Commission approved \$20,000 in funding from the Opioid Settlement Funds for the program.

Steve Cavender provided an update on Litter Control and dilapidated property activity.

Upon motion by Nibert and unanimous agreement, the Commission approved Estate Appointments, Affidavits for Small Estates, Orders Appointing Fiduciary Commissioners, Waivers of Final Settlement, Reports of Receipts and Disbursements, Commissioner's Reports of Claims and Final Settlement, and Applications for Corrections of Erroneous Assessments. Copies of which are attached hereto.

Upon motion by Johnson and unanimous agreement, the Commission minutes from the previous meeting were approved with no omissions or corrections thereto.

The Commission executed the Bills and Purchase Orders as required.

Upon motion by Nibert, the Commission approved the following EMS hires: Heather Spencer to a full-time position and Adrianna Frush to a full-time position.

Upon motion by Johnson and unanimous agreement, the Commission approved the EMS Transport Contract Amendment with Rivers Health, a copy of which is attached.

Upon motion by Nibert and unanimous agreement, the Commission approved the DLAP Grant Lien Agreement, a copy of which is attached.

The Commission received a request for cemetery plot(s) at the Henderson Cemetery and tabled the request for further consideration.

Upon motion by Nibert and unanimous agreement, the Commission approved a Resolution for Benefits for Coal Miners with Black Lung, a copy of which Resolution is attached.

Upon motion by Nibert and unanimous agreement, the Commission approved a Resolution declaring April as National County Government Month, a copy of which Resolution is attached.

The Commission tabled a decision on the sale of County property in Beech Hill.

Upon motion by Nibert and unanimous agreement, the Commission approved the purchase of a law enforcement simulator for training students to be funded with Opioid Settlement funds in the amount of \$44,095.

Upon motion by Nibert and unanimous agreement, the Commission approved paramedic pay rates, including paramedic, C3 paramedic and CCT paramedic, a copy of which is attached.

The courthouse piping project was discussed: Phase I for the replacement of sewer lines, which is currently ongoing; Phase II for the replacement of sewer piping under the Home Confinement area, which is estimated to cost \$48,990; and Phase III for water fittings, which is estimated to cost \$4,888. Upon motion by Nibert and unanimous agreement, the Commission approved Phase III only for now.

Upon motion by Nibert and unanimous agreement, the Commission approved Good Friday, April 18, 2025, as a holiday for employees and closing the courthouse for the same.

The Commission announced May 17, 2025 from 8 a.m. to 4 p.m. as county Clean Up Day at the Mason County Career Center.

The Commission noted that Nucor will hold held a tire clean-up event on April 12, 2025 from 8 a.m. to noon.

Cromley advised the Commission that her office and Secretary of State Kris Warner will conduct a voter registration drive on April 11 at the Point Pleasant High School.

The Commission signed a letter in support of the Mason County Veterans Memorial, a copy of which letter is attached.

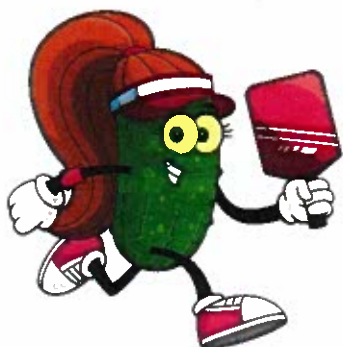
The Commission discussed the need for Wi-Fi in the courthouse, particularly in Family Court.

**AMENDMENT TO
AMBULANCE AND HEALTHCARE TRANSPORTATION SERVICES AGREEMENT**

This Amendment to Ambulance and Healthcare Transportation Services Agreement ("Amendment") is made this 10th day of April, 2025 ("Effective Date"), by and between Pleasant Valley Hospital, Inc. dba Rivers Health ("PVH"), and Mason County Emergency Medical Services ("Contractor").

WHEREAS, the parties are also parties to that certain Ambulance and Healthcare Transportation Services Agreement dated the 13th day of April, 2023, (the "Agreement"), whereby Contractor provides to PVH certain ambulance transportation and related healthcare services as more fully and particularly set forth therein; and

WHEREAS, the parties are desirous of amending the Agreement in accordance with the provisions of this Agreement.

NOW, THEREFORE, WITNESSETH, that for and in consideration of the foregoing, the mutual covenants set forth in the Agreement and in this Amendment, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Amendments.

- (a) Effective as of the Effective Date, Paragraph A is hereby deleted in its entirety and the following provision is substituted therefor:

A. Services Provided. Contractor shall provide patients of PVH with ambulance transportation services from PVH to third party healthcare hospitals or facilities (the "Services") where a patient requires higher levels of care than may be provided by PVH. Contractor shall ensure that in the provision of the Services, all patients shall be transported by at least two individuals, at least one of which shall be a trained and licensed ambulance driver and at least one of which shall be a trained paramedic certified by the West Virginia Office of Emergency Medical Services ("WVOEMS"). Contractor shall provided the Services 24 hours per day, seven days per week, 365 days per year. Contractor shall ensure that all ambulances used in the provision of the Services are equipped with all equipment necessary for interfacility transfer of patients contemplated hereunder, including, without limitation, a dedicated ventilator and shall, at a minimum, be equipped with the equipment identified on Appendix C, attached hereto. Further, Contractor shall supply all inventory, consumables, and medical supplies necessary or incident to the provision of the Services at no additional expense of PVH. This Agreement does not affect or supersede Contractor's regular provision of emergency transportation or 911 response services that Contractor provides as an emergency medical service. Contractor shall provide the Services in compliance with all standard and protocols promulgated or adopted by the WVOEMS and at or exceeding all prevailing standards of care.

- (b) Effective as of the Effective Date, subparagraph E(ii) is hereby deleted in its entirety and the following provision is substituted therefor:

(ii) Fees: PVH shall pay to Contractor a *per diem* fee of \$1,444.07 for each calendar day that Contractor provides the Services (the "Fee"), payable monthly in arrears. Contractor shall submit invoices to PVH on a monthly basis setting forth the number of full days that the Services were provided during the prior calendar month. PVH shall pay all undisputed invoices within 60 days of receipt. All payments from PVH to Contractor hereunder shall be made payable to the order of the Mason County Commission.

(iii) Gaps in Services. Each calendar day, Contractor shall contact a designated PVH representative by telephone or electronic mail for purposes of informing PVH whether Contractor expects to be able to provide the Services uninterrupted during the following 24 hours. Similarly, Contractor shall immediately inform PVH by telephone or electronic mail of any unexpected inability to provide the Services. Whether anticipated or unanticipated, Contractor may not invoice PVH for, and PVH is not required to compensate Contractor for, any time during which Contractor is not available to fully perform the Services in accordance with this Agreement, whether for reason of inadequate staffing or otherwise. Accordingly, Contractor shall reduce its invoiced amount under Subparagraph E(ii) hereof by \$60.17 for each hour that Contractor is unable to provide the Services. PVH may withhold payments improperly invoiced by Contractor for time during which the Services were not available.

- (c) Effective as of the Effective Date, the table entitled "Medications and IV Solutions" as set forth in Appendix C to the Agreement is hereby deleted in its entirety and the following table is substituted therefor:

**VOLUNTARY AGREEMENT AND LIEN AGREEMENT
BETWEEN THE MASON COUNTY COMMISSION AND PROPERTY OWNER**

This **Voluntary Agreement** (the "Agreement") is made and entered into this 10th day of April, 2025, by and between the **Mason County Commission** (the "County") and **Mason County Board of Education** (the "Owner"), collectively referred to as the "Parties".

The Owner is the legal owner of certain real property described as follows:

Property Description: Parcel 26-06-0563-0040-0000 Deed Book 114 Page 276 Hannan District

Property Address: 1 Wildcat Way, Ashton, WV 25503

1. PURPOSE OF AGREEMENT

The purpose of this Agreement is to establish a lien on the above-described property for a period of **five (5) years**, repayable on a **prorated basis** if the property is sold, transferred, or developed before the end of the lien period. Additionally, this Agreement grants the County, its agents, and assignees the right to access the property for official purposes and ensures that the property will be maintained in good condition throughout the lien period.

2. LIEN ON THE PROPERTY

In consideration for the benefits received from the County's assistance with improvements, maintenance, or other services to the Property:

- 1. Lien Duration:** A lien will be placed on the Property for a period of **five (5) years** from the date of the Agreement.
- 2. Lien Amount:** The lien shall equal the total amount of services, repairs, or other improvements provided by the County, estimated at \$_____.

- 3. Prorated Repayment:** If the Property is sold, transferred, or developed during the lien period, the Owner agrees to repay the lien amount on a prorated basis. The prorated formula shall be: **Total Lien Amount + 60 months = Monthly Prorated Repayment.** The Owner shall repay the remaining balance for the months remaining on the lien period based on the current month.

3. RIGHT OF ENTRY

The Owner grants the County, including **Litter Control Officers, contractors, surveyors, and assignees**, the right of entry onto the Property to:

- Conduct inspections and perform official business related to the Property.
- Monitor and enforce compliance with the Agreement.
- Perform necessary maintenance or litter control activities.

Such access shall be permitted at reasonable times and with reasonable notice to the Owner, except in emergency situations where immediate access may be required.

4. MAINTENANCE AND CONDITION REQUIREMENT

The Owner agrees to maintain the Property in a condition that meets local health, safety, flood zone and building codes. The Property shall not return to a dilapidated state during the lien period. If the Property is found to in violation of these requirements, the County may take necessary action to bring it into compliance with all costs added to the lien amount.

5. BINDING EFFECT

This Agreement shall bind the Parties and their respective heirs, successors, and assigns for the duration of the lien period.

6. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the State of West Virginia.

7. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the Parties and supersedes all prior oral or written understandings, agreements, or representations.

8. SEVERABILITY

If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect. The Mason County Commission reserves the right to cancel this agreement based on any findings of hazardous materials, waste or any other environmental issue that could affect the condition of the property as to the safety of the public.

9. RECORDATION OF LIEN

This document will constitute a lien on the described real estate in this agreement and will be recorded in the land records of Mason County, West Virginia.

WHEREAS Mason County is a community in West Virginia, a region with many rich assets, including our land, water, heritage, and people who have mined coal that has fueled the United States for over a century; and

WHEREAS one of the consequences of our history of coal mining has been that generations of our families and communities have suffered from high rates of black lung disease, an incurable and fatal disease caused by exposure to coal and silica dust; and

WHEREAS thousands of coal miners disabled by black lung disease and their dependents rely on federal black lung benefits including, in FY2024, 5,017 West Virginians, of which 21 claimants reside in Mason County; and

WHEREAS the federal benefits provided to residents of Mason County delivered an estimated \$475,806.68 in disability and medical benefits in 2024, providing an important financial lifeline to affected families and supporting the local economy through spending at local businesses and medical facilities; and

WHEREAS the spending value of federal black lung benefit payments have declined by over thirty percent since 1969, because black lung benefits are not tied to increases in the cost of living or rising inflation; and

WHEREAS a living wage in Mason County is over four times the amount of what is provided by federal black lung benefit rates; and


WHEREAS we are concerned about the general welfare of our mining families, specifically the impacts of rising inflation, and believe that our miners deserve to live their lives with dignity;

**Memorandum of Understanding in Support of Cooperative Ambulance Services**

Mason County Emergency Medical Services
And
Flatrock Volunteer Fire Department

This Memorandum of Understanding in Support of Cooperative Ambulance Services ("MOU") sets the terms and understanding between Mason County Emergency Medical Services ("MCEMS"), a body politic of the Mason County Commission, and Flatrock Volunteer Fire Department ("FRVFD") for emergency services (collectively "the Parties").

WHEREFORE, it is mutually AGREED by the Parties as follows:

1. Purpose. This MOU is presented for the purpose of defining operations performed between MCEMS and FRVFD.
2. Operations.
 - a. In the event of an emergency requiring emergency medical services within the FRVFD fire district, FRVFD squad will possess operational control over the scene. Control will remain with FRVFD until the emergency ceases or other higher governing agent arrives to take command. If FRVFD is not on scene, FRVFD shall not have operational control.
 - b. If the emergency is outside of the FRVFD fire district, MCEMS will possess operational control over the scene. Control will remain with MCEMS until the emergency ceases or other higher governing agent arrives to take command.
 - c. In the event that FRVFD has a squad in service for a special event, MCEMS will assume operational control and priority for the FRVFD.
3. Dispatch.
 - a. In an effort to reduce confusion, FRVFD will alert dispatch when they have a fully staffed squad available. If dispatch is not notified of a fully staffed squad, MCEMS will assume operational control and priority for the FRVFD.
 - b. In the event FRVFD is alerted for a call, and a FRVFD squad becomes operational after MCEMS was toned, MCEMS will cancel enroute, pursuant to the operations agreement made between Mason County 911 and FRVFD, made on December

7. Duration.

- a. This MOU is at-will and may be modified by mutual consent of authorized officials from the Parties.
- b. This MOU shall become effective upon signature by the authorized officials and will remain in effect until modified or terminated by any one of the parties by mutual consent.
- c. This MOU may be terminated by either party upon sixty (60) days written notice.


