THE COUNTY COMMISSION OF MASON COUNTY met in the Commission room of the courthouse on Thursday, January 22, 2026, at 2:00 p.m. in regular session. Present were Rick Handley, President; Sam Nibert, Commissioner; Chris Johnson, Commissioner; Diana Cromley, County Clerk; and Heidi Wood, Administrator.

Rick Handley called the meeting to order. Diana Cromley gave the opening prayer and Olivia Hanna led the pledge of allegiance.

Olivia Hanna and officers with the Point Pleasant Junior/Senior High School Youth Leadership Association organization gave a presentation to the Commission on the organization's current projects.

Upon motion by Johnson and unanimous agreement, the Commission approved a contribution in the amount of \$3,000 to said Youth Leadership America organization.

The Commission welcomed the new Administrator, Heidi Wood.

Upon motion by Nibert and unanimous agreement, the Commission approved Estate Appointments, Affidavits for Small Estates, Orders Appointing Fiduciary Commissioners, Waivers of Final Settlement, Reports of Receipts and Disbursements, Commissioner's Reports of Claims and Final Settlement, along with Applications for Corrections of Erroneous Assessments, copies of which are attached hereto.

Upon motion by Johnson and unanimous agreement, the Commission minutes from the previous meeting were approved with no omissions or corrections thereto.

The Commission executed the Bills and Purchase Orders as required.

The Commission discussed renovating the 2nd floor men's restroom. Clerk Cromley will obtain cost estimates on the project.

The Commission tabled until next week further discussion on selecting a vendor to contract for the county's hardware/software needs.

Upon motion by Nibert and unanimous agreement, the Commission went into executive session to discuss personnel matters.

Upon motion by Nibert and unanimous agreement, the Commission returned to regular session.

The Commission reviewed a Request for State of Preparedness, a copy of which is attached, regarding an anticipated winter weather event.

Upon motion by Nibert and unanimous agreement, the Commission approved a Resolution, a copy of which is attached, declaring a Division of Homeland Security and Emergency Management State of Preparedness for Mason County, WV, due to anticipated severe winter weather.

Upon motion by Nibert and unanimous agreement, the Commission approved Assessor Aimee Duncan's request, a copy of which is attached, to make changes in property values for the 2026 tax year.

Upon by Johnson and unanimous agreement, the Commission approved the Ballot Commissioners for the 2026 Primary Election as appointed by the Mason County Republican Executive Committee (Cary Supple) and the Mason County Democratic Executive Committee (Matthew Clark), copies of which letters are attached hereto.

The Commission was informed that the Animal Shelter wants to do a spay/neuter clinic this Spring at a projected cost of \$10,000.

The Commission welcomed Frontieras North America to Mason County, which company will be building a facility to turn coal into fuels, fertilizers and industrial carbon products.

SUBJECT: Request for Declaration of a State of Preparedness – Anticipated Winter Weather Event

Pursuant to the Mason County Emergency Operations Plan (EOP), and in anticipation of a significant winter weather event forecast to impact Mason County beginning this weekend, the Mason County Division of Homeland Security and Emergency Management respectfully requests that the Mason County Commission declare a State of Preparedness for Mason County, West Virginia.

The National Weather Service continues to forecast winter storm conditions that may include accumulating snowfall, hazardous travel conditions, extreme cold temperatures, and potential impacts to essential services. In response to this threat, Mason County will transition to a Level 2 – Increased Readiness Emergency Operations Center (EOC) posture effective at time of signing, and will remain at this level through Tuesday, January 27, 2026, unless conditions warrant further escalation.

A Level 2 EOC activation, as defined in the EOC Operations Annex of the Mason County Emergency Operations Plan, is appropriate when a disaster threatens the county and partial activation is required. Under this posture, departments and agencies with assigned responsibilities will take preparedness and coordination actions as outlined in their respective sections of the plan.

Should storm conditions worsen to a degree requiring full operational response, Mason County may escalate to a Level 3 – Response Level Activation, at which time a transition from a State of Preparedness to a Local State of Emergency would be recommended for consideration by the County Commission.

This requested declaration will allow for enhanced coordination, readiness, and situational awareness to protect the health, safety, and welfare of Mason County residents.

**STATE OF PREPAREDNESS FOR MASON COUNTY, WEST VIRGINIA
DUE TO ANTICIPATED SEVERE WINTER WEATHER**

WHEREAS, pursuant to **West Virginia Code §15-5-6**, the Mason County Commission is authorized to declare a state of preparedness or local emergency when conditions threaten the public health, safety, or welfare; and

WHEREAS the **National Weather Service** is forecasting a significant winter weather event impacting Mason County beginning this weekend and continuing through Monday, with the potential for accumulating snowfall, hazardous travel conditions, extreme cold temperatures, and disruption of essential services; and

WHEREAS, such conditions may pose a serious threat to life and property, impair emergency response operations, and impact transportation systems and critical infrastructure; and

WHEREAS, the **Mason County Emergency Operations Plan (EOP)** provides for graduated Emergency Operations Center (EOC) activation levels, and the EOC Operations Annex defines **Level 2 – Increased Readiness** as a partial activation appropriate when a disaster threatens the county; and

WHEREAS Mason County will transition to a **Level 2 EOC activation effective at 12:00 Noon today** and maintain that posture through Monday unless conditions warrant escalation;

NOW, THEREFORE, BE IT RESOLVED BY THE MASON COUNTY COMMISSION, that a **State of Preparedness** is hereby declared for **Mason County, West Virginia**, effective immediately upon adoption of this resolution.

BE IT FURTHER RESOLVED that all county departments, municipalities, and emergency service organizations shall take appropriate preparedness actions and coordinate through the Mason County Division of Homeland Security and Emergency Management in accordance with the Mason County Emergency Operations Plan.

BE IT FURTHER RESOLVED that the Director of the Mason County Division of Homeland Security and Emergency Management and Director of Mason County Office of Emergency Services is authorized to coordinate preparedness operations, activate EOC functions consistent with a Level 2 Increased Readiness posture, and disseminate public safety information as conditions warrant.
