THE COUNTY COMMISSION OF MASON COUNTY met in the Commission room of the courthouse on Thursday, March 12, 2026, at 2:00 p.m. in regular session. Present were Rick Handley, President; Sam Nibert, Commissioner; Chris Johnson, Commissioner; Diana Cromley, County Clerk; and Heidi Wood, Administrator.

Rick Handley called the meeting to order. Diana Cromley gave the opening prayer and Alivia Grigsby led the pledge of allegiance.

Wahama High School art students who participated in the "I Voted" sticker contest were recognized by the Commission, including First Place winner Mazi Russell and Honorable Mentions, Maelin Smith and Abigail Miller.

Point Pleasant High School choir member, Alivia Grigsby, was also recognized by the Commission. She was chosen for the All American Chorus and will be traveling to Normandy this summer.

Stephen Littlepage with the Claflin Foundation and Brent Hereford on behalf of the Mason County Career Center appeared before the Commission for the presentation of a grant award for the extension of the bleachers at the Fairground Show Ring.

Tara Chambers and Kyla Pope with the Letart Lunch Box program appeared before the Commission and were presented with a Business of the Quarter award.

Upon motion by Nibert and unanimous agreement, the Commission approved Estate Appointments, Affidavits for Small Estates, Orders Appointing Fiduciary Commissioners, Waivers of Final Settlement, Reports of Receipts and Disbursements, Commissioner's Reports of Claims and Final Settlement, along with Applications for Corrections of Erroneous Assessments, copies of which are attached hereto.

Upon motion by Johnson and unanimous agreement, the Commission minutes from the previous meeting were approved with no omissions or corrections thereto.

Upon motion by Johnson and unanimous agreement, the Commission approved the list of poll workers, polling places and Emergency Absentee Ballot Commissioners for the 2026 Primary Election, copies of which are attached.

The request of Flatrock Fire Department to be given the Route 87 fire station property was tabled until April 16, 2026 for further consideration.

Upon motion by Sam Nibert and unanimous agreement, the Commission approved the hire of Ben Halley to a full-time position with the Animal Shelter effective March 16, 2026 with a 90-day probationary period.

Upon motion by Chris Johnson and unanimous agreement, the Commission approved the following hires: Abbey Cummins, Marley Buskirk and John Sturgeon to part-time positions as telecommunicators with the 911 Center effective March 16, 2026; Kia Satterfield to a full-time position as a telecommunicator with the 911 Center effective April 1, 2026; and Destinee Spry to a full-time position as an EMT with the EMS effective March 16, 2026.

Upon motion by Nibert and unanimous agreement, the Commission approved moving \$160,000 to the General Fund for 911 software and equipment upgrades.

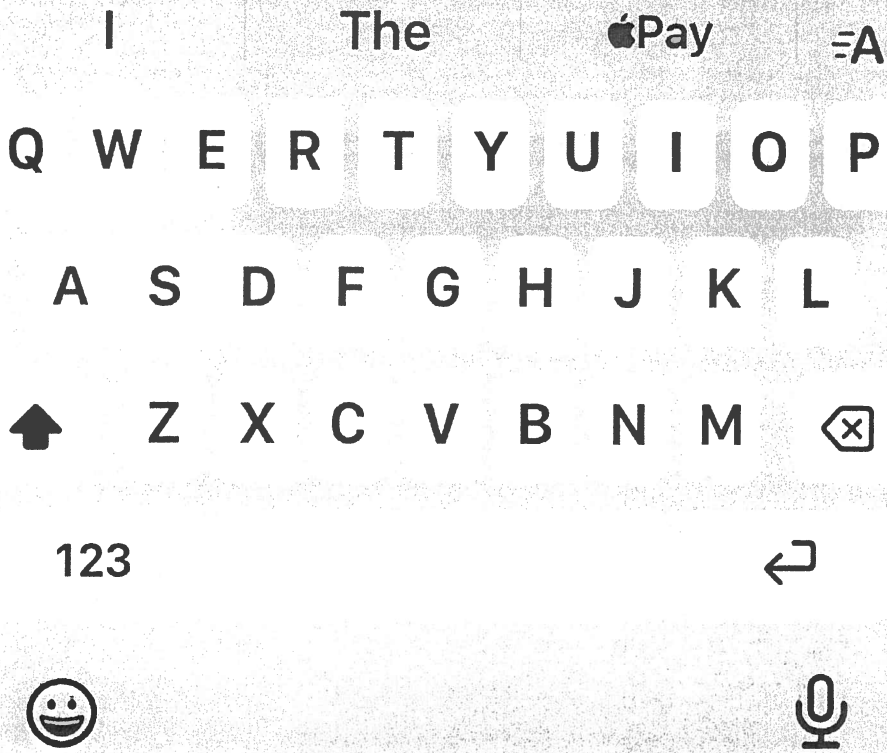
